WHEREAS it appears by Messages from His Excellency Sir Preamble.
GEORGE GREY Knight Commander of the Most Honorable Order of
the Bath Governor and Commander-in-Chief in and over Her Majesty's
Colony of New Zealand and its Dependencies and Vice Admiral thereof
and by the Estimates accompanying the same that the sums herein-
after mentioned are required to defray certain expenses of the Govern-
ment of this Colony and of the Public Service thereof and for other
purposes for the year ending on the thirtieth day of June one thousand
eight hundred and sixty-six

BE IT THEREFORE ENACTED by the General Assembly of New Zealand
in Parliament assembled and by the authority of the same as follows—

VI. The Treasurer of New Zealand shall issue and pay the said several sums hereby appropriated to such persons for the purposes hereinbefore mentioned upon such days and in such proportions as the Governor may by any warrant to be signed by him from time to time order and direct and the payment so to be made shall be charged upon and payable out of such Revenue as aforesaid.

bursements.

VII. The said Treasurer shall in his accounts from time to time be allowed credit for any sum of money paid by him in pursuance of any warrant issued by virtue of this Act and the receipt of the person to whom the same shall be so paid shall be a full and valid discharge to the said Treasurer in passing his said accounts for any such sum as shall be therein mentioned.
