
An Act to authorize the Municipal Council of the Title. Town of Port Chalmers to raise Money for the purpose of constructing Waterworks for the supply of the Town and the Shipping of the Port with [15th September, 1873.] Water.

THEREAS it is expedient to authorize the Municipal Council of Preamble. the Town of Port Chalmers to raise money for the purpose of constructing waterworks for the supply of the town and the shipping of the port with water as hereinafter mentioned:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same,

1. The Short Title of this Act shall be "The Port Chalmers Short Title. Waterworks Act, 1873."

2. The Municipal Council of the Town of Port Chalmers may Municipal Corporaborrow any sum or sums of money not exceeding in the whole the may borrow money sum of fifteen thousand pounds, and may secure the repayment of for waterworks. the same with interest in manner provided by "The Municipal Corporations Waterworks Act, 1872," and may apply the same in the construction or purchase of waterworks, under the provisions of the said Act, for the supply of the Town of Port Chalmers and the shipping of the port with water: Provided always that no money shall be raised under the provisions of this Act until the undertaking shall have become a duly authorized undertaking within the provisions of the said Act.

Title. Preamble. 1. Short Title. 2. Land to be vested in the Queen.

The Christchurch Cathedral Square Act, 1873. Title. [15th September, 1873.]

HEREAS the parcel of land described in the Schedule to this Preamble. Act is now vested in the Superintendent of the Province of Canterbury and his successors, upon trust, as a public recreation ground or garden, or as an open square, or for plantations: And whereas the Provincial Council of the Province of Canterbury have by resolution agreed that the said land should be appropriated and used as a site for Custom House, Post Office, Telegraph Office, and other public buildings for the use of the General Government: And whereas it is intended to erect public buildings upon the said land, and it is expedient that the fee-simple of the said land should be vested in the Crown freed and discharged from the aforesaid or any trusts upon which the same is now or has heretofore been held:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:-

1. The Short Title of this Act shall be "The Christchurch Short Title.

Cathedral Square Act, 1873."

2. The land described in the Schedule hereto is hereby divested Land to be vested from the said Superintendent, or any other person or persons or Cor- in the Queen. poration in whom the same is now vested, and is hereby vested in Her Majesty the Queen, freed and discharged of all trusts upon which the same was immediately before the passing hereof held, and such land shall henceforth be deemed to be land reserved as a site for

Christchurch Cathedral Square.

public buildings for the use of the General Government of New Zealand: Provided that nothing in this Act contained shall authorize the removal of, or any interference with, the statue of the late John Robert Godley, now erected on the said land, unless with the approval of the Superintendent and Executive Council of Canterbury.

Schedule.

SCHEDULE.

All that piece or parcel of land, containing by admeasurement one acre and fourteen perches, more or less, being the western portion of reserve numbered 1 (in red) on the map of the Chief Surveyor of the Province of Canterbury setting out and describing the Town of Christchurch; commencing at a point on the northern boundary of that reserve where it is intersected by a curve one chain distant from and parallel to the curve laid down as the western boundary of the footpath fronting the Cathedral site; thence westerly, southerly, and easterly to the intersection of the first-mentioned curve by the southern boundary of said reserve.
