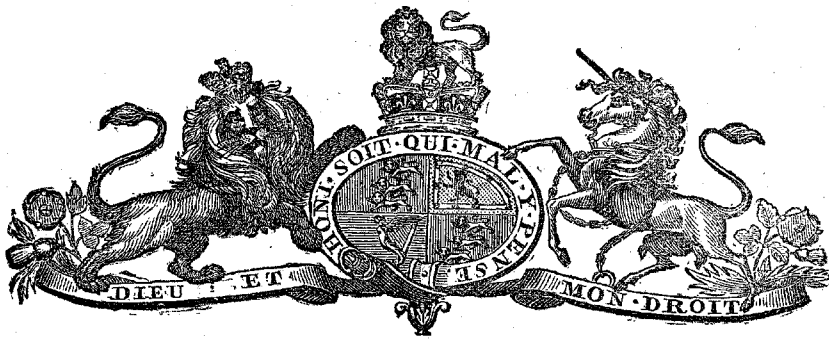

AN ACT to extend the Currency of certain Treasury Bills. Title.
[29th September, 1873.]

BE IT ENACTED by the General Assembly of New Zealand, in Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act shall be "The Treasury Bills Extended Currency Act, 1873." Short Title.

2. In order to provide for the payment of the principal moneys of any of the Treasury Bills issued under the authority of "The Treasury Bills Act, 1869, No. 2," and, except as hereafter provided, under "The Treasury Bills Extended Currency Act, 1870," the Colonial Treasurer may order the preparation and issue of a like amount of Treasury Bills. Treasury Bills under Acts of 1869 and 1870 may be reissued.

3. All Bills made out under the authority of this Act shall, except as hereafter provided, be prepared made out and issued in the manner prescribed by "The Treasury Bills Regulation Act, 1868," and any Act amending the same, and shall bear interest at any rate not exceeding six pounds for every one hundred pounds by the year, in respect of the whole moneys contained therein, as the Colonial Treasurer may from time to time fix, and such Bills may be renewed and reissued from time to time: Provided always that the currency of such Bills shall in no case be made to extend beyond the first day of November, one thousand eight hundred and eighty-two. 4.
