- 1. The Short Title of this Act is "The Imprest Supply Act, 1880 (No. 4)."

Out of the Public Account there may be issued and applied, towards making good the Supply granted to Her Majesty by way of Imprest for the service of the year ending the thirty-first day of March, one thousand eight hundred and eighty-one, in addition to the sums mentioned in the Civil List Act. "The Imprest Supply Act, 1880," "The Imprest Supply Act, 1880 (No. 2)," "The Imprest Supply Act, 1880 (No. 3)," and other Acts, any sums of money not exceeding in the whole two hundred thousand pounds (£200,000), to be charged in the manner hereafter to be expressed in any Act or Acts passed in this present session of Parliament for appropriating the Public Revenues of the colony for the year ending the thirty-first day of March, one thousand eight hundred and eighty-one.

DISEASED CATTLE PROCLAMATIONS VALIDATION.

Short Title.

An Act to validate certain Proclamations purporting to have been made under "The Diseased Cattle Act, 1871."

[27th August, 1880.]

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

- 1. The Short Title of this Act is "The Diseased Cattle Proclamations Validation Act, 1880."
- 2. All acts, matters, or things made or done by any person under or in virtue of any Proclamation, Order in Council, notification, or appointment purporting to be made under "The Diseased Cattle Act, 1871," or under "The Diseased Cattle Act Amendment Act, 1873," are hereby declared to be and to have been valid and effectual to all intents and purposes from the date on which any such act, matter, or thing may have been made or done respectively, notwithstanding that any such Proclamation, order, notification, or appointment may have been made before the fourteenth day of August, one thousand eight hundred and seventy-two, which was the day appointed for the coming into operation of the Act hereinabove first mentioned.

JOINT-STOCK COMPANIES ACT 1860

AMENDMENT.

Preamble.

An Act to amend "The Joint-Stock Companies Act, 1860."

[27th August, 1880.]

WHEREAS it is desirable to further amend "The Joint-Stock Companies Act, 1860:"

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:-

- 1. The Short Title of this Act is "The Joint-Stock Companies Act 1860 Amendment Act, 1880."
- 2. Where any association is about to be formed under "The Joint-Stock Companies Act, 1860," as a limited company, if it proves to the Registrar of Joint-Stock Companies in the district in which such association seeks to be incorporated, that it is formed for the purpose of promoting commerce, art, science, religion, charity, or any other useful object, and that it is the intention of such association to apply the profits, if any, or other income of the association in promoting its objects, and to prohibit the payment of any dividend to the

Association may be formed under "Joint Stock Companies Act, 1860, without addition of term "limited." members of the association, the said Registrar may, by license under his hand, direct such association to be registered with limited liability without the addition of the word "limited" to its name; and such association may be registered accordingly, and upon registration shall enjoy all the privileges and be subject to the obligations by the said Act imposed on limited companies, with the exceptions that none of the provisions of the said Act that require a limited company to use the word "limited" as any part of its name, or to publish its name, or to send a list of its members, directors, or managers to the Registrar, shall apply to an association so registered.

3. The license by the said Registrar may be granted upon such conditions as License may be may be prescribed by regulations made by the Governor in Council; and such granted on conditions conditions (if any) shall be binding on the association, and shall be inserted in regulations. the memorandum of association and indorsed on the certificate of incorporation.

4. When any liquidator in a voluntary winding-up has heretofore or shall When liquidator become bankrupt within the meaning of any law for the time being in force shall cease to act. relating to bankruptey, or has left or shall leave the colony to reside abroad, he shall cease to be a liquidator. This provision shall apply to all cases heretofore occurring, but shall not operate to prejudicially affect any acts or things heretofore done by such liquidator.

5. Whenever by death, resignation, or otherwise, any liquidator in a volun- Vacancies. tary winding-up has ceased or shall cease to hold office, the surviving or continuing liquidator or liquidators, until the appointment of some other person to fill the vacancy so occasioned, shall be and be deemed to have been, as from the date of such vacancy occurring, empowered to act alone, as if he or they had been the sole liquidator or liquidators.

6. Whenever a company is being wound up voluntarily the company may, Liquidators may be in general meeting, remove any liquidator or liquidators.

7. If any vacancy has occurred, or shall occur, in the office of liquidator Vacancies how filled appointed by a company in a voluntary winding-up, by death, resignation, up. removal, or otherwise, the company in general meeting may fill up such vacancy. A general meeting for such purposes as aforesaid, may be convened by the continuing liquidators or liquidator, if any, or by any contributory of the company; and shall be deemed to have been duly held, if held in manner prescribed by the regulations of the company, or in such other manner as may, on application by the continuing liquidator, if any, or by any contributory of the company, be determined by the Court.

8. If from any cause whatever there is no liquidator acting in the case of a If there be no liquivoluntary winding-up, or if the company neglect to fill up any vacancy occurring appoint. in the office of the liquidators, the Court may on the application of a contributory appoint a liquidator or liquidators; the Court may also, on due cause shown, remove any liquidator and appoint another liquidator to act in the matter of a voluntary winding-up.
