AN ACT to amend "The Rohe Potae Investigation of Title Act, Titler 1892." [2nd September, 1893.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :---

1. The Short Title of this Act is "The Rohe Potae Investigation short Title. of Title Act Amendment Act, 1893."

2. The several orders of the Native Land Court, made at a sit- Orders specified in ting of the Court at Otorohanga between the date of the passing of Schedule to be deemed further "The Rohe Potae Investigation of Title Act, 1892," and the twenty- orders under the third day of November, one thousand eight hundred and ninety-two, as the same are particularly specified in the Schedule hereto, shall be deemed to have been "further orders" within the meaning of the said Act, and shall be as valid and effectual for all intents and purposes as if such orders had been made and dated prior to the coming into operation of the said Act: Provided that any person who shall consider himself aggrieved by the making of any such order may, at any time within three months from the passing of this Act, apply for a rehearing as if such order had been made and dated on the day of the passing of this Act.

3. Notice of the passing and of the effect of this Act shall Notice to Natives. immediately be given to the Natives affected by the orders in the Schedule hereto, in such manner as the Governor in Council shall determine.
